What is the organization's primary exempt purpose?

We "Invent in the public, for the Public." We research new inventions that benefit the public, specifically the poor and distressed. We engage in community building activities (such as conferences) to help recruit volunteers interested in creating new inventions and helping develop and validate the skills necessary for those individuals to be successful. In 2021, we primarily worked on humanitarian engineering in the form of open-source ventilators, oxygen concentrators, and test equipment. We maintained our programs in mathematical publication and water quality analysis.
