Public Invention alleviates poverty and advances education, science, and engineering by creating teams of mostly unpaid volunteers who "Invent in the public, for the Public". All of our activities are open-source and shared with all businesses and persons under open source licenses. We seek to create a movement for open science and invention similar to the open source software movement, but including inventions which help humanity, such as biomedical devices.

We had a contract with NASA to develop and deliver a digital control system to drive a solid-state oxygen generator. This device is just beginning commercialization and technology transfer (to another firm) by NASA. This will fill spacesuits, allow the tankage of O2 as a rocket oxidizer necessary for refueling rockets, and scrub dangerous oxygen for gases to be processed in space. Additionally, this could revolutionize treatment of childhood pneumonia, which kills at least a quarter of a million children around the world every year, because it can be scaled down to the size of a single clinical bed, and is expected to be very reliable.

The Global Distributed Tracking (GDT) project of the Global Open Source Quality Assurance System (which we lead) addresses the problem of substandard and falsified medical devices in the global supply chain. We have created an open-source fully encrypted, anonymously usable track-and-trace system that does not require authentication in low- and middle-income countries. This works by placing a QR code on a device, box, carton, or crate. Anyone with a smartphone can amend the history of the item or group of items. The website is live now: <https://gosqas.org/>.

EcoPot is an attempt to design more efficient cooking pot specifically for the one billion people on Earth who still cook on an open wood fire. This is very inefficient. It requires a great deal of fuel to be gathered or cut, keeping the poorest in poverty. It produces unhealthy smoke, and adds (slightly) to global warming. We are using computation fluid dynamics to attempt to design a more efficient design. This methodology will be shared with the world to create a "challenge", allowing all to participate. We may build a test apparatus for testing pots in miniature, and eventually in full family-size designs.
